INSTRUCTIONS FOR USE OF POST JUDGMENT DOMESTIC VIOLENCE FORMS FOR HEARINGS BEFORE GENERAL MAGISTRATES AND CHILD SUPPORT HEARING OFFICERS, FORMS REVISED MAY 2008

THE MOTION FOR MODIFICATION MUST BE FILED AND COMPLETED WITH THE ASSISTANCE OF THE CLERK OF COURT. FORMS MUST BE FILED IN-PERSON AT THE CLERK'S OFFICE. THE CLERK WILL MAIL COPIES TO ALL PARTIES AND PROVIDE INSTRUCTION ON SCHEDULING A HEARING.

The attached forms are for use only in post-judgment domestic violence injunction cases in which a party requests that one or more of the following issues involving minor children be addressed:

1. Contempt for failure to comply with the child support order in the domestic violence case,
2. Contempt for failure to comply with the minor child visitation provisions of the Final Judgment of Injunction,
3. Modification of the Injunction to add or change child support,
4. Modification of the Injunction to add or change minor child visitation.
5. Modification of the Injunction to change child custody

If the parties are seeking modification of other terms of the Injunction, Supreme Court Approved Form 12.980(j) should be used.

Confidential Addresses: The procedure for confidential addresses is unchanged. Please be sure no Petitioners' confidential addresses appear on pleadings or other paper that will be in the court file and/or served on the parties. Instead, "Confidential" should be written on the line provided for the Petitioner's address.

PLEASE BE SURE THAT THE INJUNCTION HAS NOT EXPIRED OR BEEN DISMISSED BEFORE FILING. THERE CAN BE NO FURTHER LITIGATION IN THIS CASE AFTER DISMISSAL OR EXPIRATION OF THE INJUNCTION
