ADMINISTRATIVE ORDER NO. 2014-015 PA/PI-CIR

**RE: AMENDMENT TO IMPLEMENTATION OF PROCEDURES RELATING TO
VIOLATIONS OF INJUNCTIONS FOR PROTECTION AGAINST VIOLENCE
AND STALKING**

It is necessary to amend Administrative Order 2012-053 to incorporate Florida Supreme Court Approved Family Law Forms 12.980(w) and 12.980(x), as adopted by the Supreme Court on May 9, 2013. See *In re Amendments to the Florida Supreme Court Approved Family Law Forms*, 113 So.3d 781 (Fla. 2013). Those two forms are appropriate to use instead of Attachments A and D to the Administrative Order.

In accordance with Article V, section 2, Florida Constitution, Rule of Judicial Administration 2.215, and section 43.26, Florida Statutes, it is

ORDERED:

Administrative Order 2012-053 is amended by substituting any reference to Attachment A or the "Affidavit in Support of Violation of Injunction," with Florida Supreme Court Approved Family Law Form 12.980(w), Petition by Affidavit for Order to Show Cause for a Violation of Final Judgment of Injunction for Protection Against Domestic Violence, Repeat Violence, Dating Violence, or Sexual Violence, or Stalking.

Administrative Order 2012-053 is amended by substituting any reference to Attachment D or the "Order to Show Cause and Scheduling Criminal Contempt Arraignment" with Florida Supreme Court Approved Family Law Form 12.980(x), Order to Show Cause.

All other terms and conditions of Administrative Order 2012-053 remain in full force and effect.
