

ADMINISTRATIVE ORDER #83-76

ORDER AUTHORIZING USE OF A REVISED
COMPLAINT/ARREST AFFIDAVIT, COUNTY CRIMINAL FORM NUMBER 59

This Order supersedes Administrative Order #83-20.

Effective immediately, all agencies in Pinellas County who are authorized to issue Complaint/Arrest forms, in County and Circuit court cases, are hereby authorized to use the attached CO CR Form 59, revised September, 1983, as the official Complaint/Arrest Form, in cases where an arrest is involved. It will also be permissible for the above agencies, where an arrest is involved, to continue to utilize CO CR Form 59, revised February, 1983, until that supply of forms is exhausted. Thereafter, all of the above-named agencies will exclusively use CO CR Form 59, revised September, 1983.


Effective immediately, upon receipt of CO CR Form 59, revised September, 1983, all agencies in Pinellas County who are authorized to issue Notice to Appear forms for County Court, must exclusively use CO CR Form 59, revised September, 1983, in Notice to Appear cases, where the defendant is being released at the site of the Notice to Appear issuance, with the following exceptions:

Any state or county agencies which have been issued pre-printed forms for Notice to Appear, which comply with Rule 3.125, Florida Rules of Criminal Procedure, are hereby authorized to continue to use that pre-printed form in Notice to Appear cases only.

Any case involving an arrest where the defendant is transported to the Pinellas County Jail will require utilization of CO CR Form 59.

All agencies in Pinellas County issuing Notice to Appear forms are required to comply with the reverse side of the original concerning "Schedule of Witnesses and Evidence; Notice to Appear Only". Any agency who prefers to provide that information on a separate sheet of paper, may do so, providing that that agency exactly duplicates the provided format for this information, and provides that information to the Clerk of Court upon filing the original Notice to Appear document. Upon receipt of the original Notice to Appear, with the reverse side information not completed, or submitted on a separate sheet, this Court may require the issuing officer to appear at the Criminal Court Complex, and complete the necessary form for the Clerk of Court.

5100-144th Avenue, North, Clearwater, Florida 33520

WITHIN TEN (10) DAYS OF THE DATE OF THE OFFENSE(S), AND PAY THE FINE BY CASH, MONEY ORDER, OR CERTIFIED CHECK, PAYABLE TO THE CLERK OF THE CIRCUIT COURT.

THE WAIVER BELOW MUST BE COMPLETED AND ATTACHED. READ CAREFULLY.

YOUR FAILURE TO ANSWER THIS SUMMONS IN THE MANNER SUBSCRIBED WILL RESULT IN A WARRANT BEING ISSUED ON A SEPARATE AND ADDITIONAL CHARGE.
