### **Pro Se Assistance: Court Administration, Courts Information and Resource Center**

- This program provides procedural assistance to the public. Staff will assist self-represented litigants set family law cases for hearing and information regarding family law forms. Staff is prohibited from giving legal advice. Hours of operation - Monday through Friday 8:00 a.m. - 12:00 p.m. and 1:00 p.m. to 5:00 p.m. This office serves St. Petersburg and Clearwater sections. **Self-Help Center – Pinellas Clerk of Court, 6<sup>th</sup> Judicial Circuit & Community Law Program**- This program offers affordable consultations with an attorney, provides software for completing eviction, divorce and small claims forms, and provides forms and packets for Family, landlord/tenant and small claims actions. **Legal Resource Center – Pasco Clerk of Court, 6<sup>th</sup> Judicial Circuit** – The center offers multiple self-help services to the public.
