Procedures for Motions

St. Petersburg Child Support Hearing Officer

Before the Child Support Hearing Officer can hear your case, you must first put in writing **what** you are asking the Court to do and **why**. Usually this is done in the form of a Motion.

In order to get a hearing on your motion you must:

- 1. Complete the attached form and file the original with the clerk of the circuit court in the county where your child support order was entered. Please keep a copy for your records. If your child support order was entered in another state or if the child(ren) live in another state, you should speak with an attorney about where to file this form.
- 2. Mail copies of the motion to:

The other party (Custodial Parent/Relative or Non-Custodial Parent) or their attorney. Visit the clerk's office and review the court file for the other party's address.

3. Once the motion has been mailed, you must call the Office of the Child Support Hearing Officer at (727) 582-7732 for a hearing date. No hearing will be set on your motion unless you request a hearing date from the Office of the Child Support Hearing Officer. All hearings in St. Petersburg for child support are conducted at: 545 First Avenue N, 3rd Floor, Room 302, St. Petersburg, FL 33701.
