**\*\*PROBATE/GUARDIANSHIP:** Once you file a motion and need hearing time, please send an Email to [UFCE1@jud6.org](mailto:UFCE1@jud6.org). Please include the case number and length of time needed for hearing. The Judicial Assistant will provide available dates and times. Please coordinate with opposing counsel before we reserve time for the hearing. Once we provide hearing times, do not include the Judicial Assistant in the coordination emails, only the final email with a coordinated date and time. These dates and times are fluid and we do not reserve them.

If your hearing can be cancelled, please email [UFCE1@jud6.org](mailto:UFCE1@jud6.org) and notify us. A notice filed with the Clerk will not always notify the Judge's office of the cancellation.

Orders can be uploaded in JAWS. The Clerk will review the documents prior to submission to Judge Babb. If you have questions about the Orders, please contact the Clerk first. DO NOT email Orders directly to the Court unless you are specifically directed to do so by her Judicial Assistant. However, do not submit any orders with Judge Babb's signature being the only thing on the signature page.

**PROCEDURAL ORDER REGARDING COURT ORDERS IN EAST SIDE  
DEPENDENCY COURT UPLOADED IN JAWS FOR SIGNATURE**

EFFECTIVE IMMEDIATELY, any Orders that are prepared for the Court's signature, by any party, (in East Pasco Dependency cases) are to be sent for review to every attorney on the notice list for review. Upon sending the proposed Order to all parties, hold the Order for three (3) days.

After three (3) days:

NO OBJECTION FROM ANY PARTIES: Upload in JAWS for signature.

OBJECTION FROM ANY PARTIES: Attempt resolve amongst parties, if not able, provide the Order to my office via hard-copy with a memo explaining support for your Order or objection to the Order. The Court will then review the Order and explanations. Thereafter, an Order will be signed and provided to the Clerk.
