RE: APPOINTMENT OF REFEREE

WHEREAS, the Chief Justice of the Supreme Court of Florida has designated the Chief Judge of the Sixth Judicial Circuit of Florida to appoint a referee for the Court to preside in a disciplinary action brought by The Florida Bar pursuant to the Rules Regulating The Florida Bar,

IT IS ORDERED that the Honorable William H. Burgess III, Circuit Judge, in and for the Sixth Judicial Circuit, State of Florida, having certified to the Chief Judge that he has reviewed the referee training materials approved by the Supreme Court of Florida, is hereby designated and appointed as referee for the Florida Supreme Court, in the matter of:

Supreme Court Case No. SC2026-0956.

The Honorable William H. Burgess III, as referee, is hereby vested with all and singular the powers and prerogatives conferred by the Constitution, laws of the State of Florida, and the Rules Regulating The Florida Bar, concerning a referee for the Supreme Court of Florida in this matter.

The Honorable William H. Burgess III, as referee shall hear, conduct, try, and determine matters presented and shall submit findings of fact and recommendations to the Supreme Court of the State of Florida as provided in Rule 3-7.6(m) and in accordance with the June 23, 2026 order of Chief Justice Muñiz. The referee's report shall be filed in accordance with said order.
